Availability of materials related to agenda items for public inspection does not include materials that are exempt from public disclosure under Government Code sections 6253.5, 6254, 6254.3, 6254.7, 6254.15, 6254.16, or 6254.22.

Nothing in this section shall require or authorize a disclosure of information prohibited by state or federal law.

If all matters are not completed, the Board will suspend closed session and open the public portion of the meeting at 9:00 a.m. Any remaining closed session matters will be heard at the conclusion of the public portion of the meeting.

CLOSED SESSION may be called for labor negotiations (pursuant to Government Code §54957.6), personnel matters (pursuant to Government Code §54957), real estate negotiations/acquisitions (pursuant to Government Code §54956.8), and/or pending or potential litigation (pursuant to Government Code §54956.9). Following Closed Session the Board will announce any action taken in Open Session.
